

RESOLUTION NO. 61-2023

**A RESOLUTION OF THE TOWNSHIP COMMITTEE
OF THE TOWNSHIP OF HANOVER ADOPTING THE REVISED 2023
CALENDAR YEAR BUDGET FOR HANOVER TOWNSHIP FIRE
DISTRICT NO. 2**

WHEREAS, on February 18, 2023, the legal voters of Fire District No. 2 defeated the 2023 Fire District Budget held at the election; and

WHEREAS, pursuant to N.J.S.A. 40A:14-78.5b, the Hanover Township Committee shall, within 30 days after the annual election, prepare and adopt by resolution of the majority of the full membership of the Township Committee, the budget for the Township of Hanover Fire District No. 2; and

WHEREAS, pursuant to the state statute, the governing body of the Township of Hanover convened a public hearing on the defeated budget on Thursday evening, March 9, 2023.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

1. That the Township Committee of the Township of Hanover hereby adopts the Township of Hanover Fire District No.2 budget by making the following line-item changes to the budget submitted to the voters by the Township of Hanover Fire District No. 2 as follows:




