The 2026 budget is increasing \$68,980 from the 2025 budget primarily due to the increases in operating expenses (see page F-3 for detail). The 2026 budget is still within the budget "cap."

Administrative S&W & related fringe benefits - increase of \$35,768 or 160% due to increased hours as well as PERS pension bill being fully allocated here instead of a large portion to operations fringe benefit (PERS firefighter is no longer with the District).

Other Admin Expenses – office supplies increased \$3,000 or 30% due to inflationary increases.

Ops & Maint Fringe benefits - increase of \$42,609 or 10% mainly due to increase in health benefits and pension. Health benefit increase is due to increase in premiums.

Other Op. & Maint. Expenses - see page F-3 Details for explanation of items with variance over 10%

LOSAP - increase of \$10,000 due to increased contribution.

Capital appropriations - decrease of \$30,000 - less set aside in the Reserve for Future Capital Outlays
